BOARD MANAGEMENT SOFTWARE OVERVIEW

Board management software offers a work space for professionals such as chief executives and board members. They can utilize it to plan progress, make timely decisions, and stay organized. This collaborative tool provides access to contacts, calendars, notes, files, and agendas that can be employed to inform corporate meetings. You can upload files in the work space and assign access to users based on their roles and permission levels.

Board software can be employed along with team collaboration solutions that are commonly used by meeting participants and company employees. In short, a board management software has the following characteristics: is used by committee or board members (and similarly ranked directors), enables you to create and store materials like team notes, meeting minutes, agendas, and more, facilitates engagement and communication between members, and offers features to garner group feedback.

Market Presence Score is affected by:

1. Social media followers including LinkedIn, Twitter, & Facebook
2. Vendor momentum based on web traffic and search trends
3. Organic SEO key term rankings
4. Company presence including # of press mentions

Company Score is affected by:

1. Total # of employees (based on social media and public resources)
2. Year-over-year change in # of employees over past 12 months
3. Glassdoor ranking
4. Venture capital raised
